

Tobacco Valley Gun Transfer Guidelines

Tobacco Valley Gun must have you fill out the *transfer form* below correctly to either have a firearm shipped to us or to have your firearm shipped from us.

*Without this information we will **NOT** authorize receiving any of your orders to our store.

You **MUST** have one of the following Connecticut Compliant Documentation to receive transferred firearms:

- Connecticut Permit to Carry Pistol or Revolvers
 - This allows you to receive any CT Compliant Firearm.
- Connecticut Eligibility Certificate for the Purchase of Pistols or Revolvers
- Connecticut Eligibility Certificate to Purchase Long Guns
 - This allows you to receive any CT Compliant Long Gun.
 - You cannot receive any Hand Guns, Others, or Receivers with this certificate.
 - You **MUST** be over 21 to receive any Long Gun that is a semi-auto centerfire, with a detachable magazine, if you only have a Long Gun Certificate.
- Active Law Enforcement Identification
- Active Military Identification

If you do **NOT** have one of these applicable permits, we will not let you receive the firearm, we will not hold the firearm, and the firearm will be shipped back at your expense. This includes any expired Permit as well. No exceptions.

General Guidelines:

- Fees:
 - \$50.00 per incoming Firearm.
 - \$50.00 per outgoing Firearm.
 - Additional shipping per outgoing firearm.
 - This means if you want a firearm shipped out total cost is will be quoted for location.
 - \$50.00 per person to person.
 - \$100.00 Estate Processing Fee
 - This plus \$50.00 per Firearm.
- All transfers will require a minimum 24-hour processing time from when they are **delivered** to our store. This includes incoming or outgoing firearms.
 - Following the delivery truck will incur an additional fee of \$25.00 per

firearm and will not be available for pickup until the 24-hour processing time is reached.

- Transfers can be picked up any time after the 24-hour processing time during opened store hours; however, it is at our discretion to perform them.
 - If the store is busy at peak hours, we may ask you to come back.
 - Any hostility will be met with a return of your firearm at your expense.
- Time limits on holding your firearm transfers.
 - If you do not pick up your firearm within 6 months of delivery, you will forfeit ownership of the firearm.
- All **incoming** transfers have to contact us for our FFL information.
 - We will not give you, our information.
 - We will not contact the Seller for their information.
 - They must contact us if you bought the firearm from them.
 - You must fill out the Transfer Form prior to shipment.
 - Will not receive firearms from individuals.
 - It must be from a licensed FFL dealer.
 - We will NOT accept transfers directly from Smith & Wesson at this time.
- All **outgoing** transfers will be contacted by us for their FFL information.
 - We do not receive FFL information from you, unless you are a responsible party on said FFL.
 - You must fill out the Transfer Form with their Phone number and Email for us to contact them.
 - We will not send firearms to individuals because it is illegal.
 - Additional flat rate shipping fees will be charged at your expense.
 - We will not accept/use your own shipping labels.
 - We will not use any other shipping service of your choice.
 - We will provide tracking numbers upon request.
 - Please email us to forward a tracking number to you.

ALL FIREARMS MUST MEET STATE AND FEDERAL REGULATIONS.

Please read specific regulations below for more details of what is Connecticut Compliant.

We will **NOT** transfer an "Assault Weapon." Proof of a manufacture date must be provided for any such firearm. The State of Connecticut Department of Emergency Services and Public Protection considers all AR-15s and AK-47s, as well as numerous other rifles to be "Assault Weapons". Hand Guns (Pistol/Revolver)

- Hand Guns must be compliant with all Federal and Connecticut State Regulations.
- Hand Guns with the following features are NOT acceptable:
 - A semiautomatic pistol that has the ability to accept a detachable magazine and have at least one of the following:
 - An ability to accept a detachable magazine that attaches at some location outside of the pistol grip.
 - A threaded barrel capable of accepting a flash suppressor forward pistol grip or silencer.
 - A semiautomatic pistol with a fixed magazine that has the ability to accept more than 10 rounds.
 - A shroud that is attached to or partially or completely encircles, the barrel and that permits the shooter to fire the firearm without being burned, except a slide that encloses the barrel.

Long Guns (Rifle/Shotgun)

- Long Guns must be compliant with all Federal and Connecticut State Regulations
- Long Guns with the following features are NOT acceptable:
 - A semiautomatic, centerfire rifle that has an ability to accept a detachable magazine and has at least one of the following:
 - Folding or telescoping stock
 - Any grip of the weapon including a thumbhole stock or any other stock, the use of which would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing.
 - Forward pistol grip
 - Flash suppressor
 - Grenade Launcher
 - Flare Launcher
 - Fixed Magazine that accepts more than 10 rounds
 - Overall Length of less than thirty inches
 - A semiautomatic, centerfire rifle that has a fixed magazine with the ability to accept more than 10 rounds.
 - A semiautomatic shotgun that has the ability to accept a detachable magazine.

- A shotgun with a revolving cylinder or; A part or combination of parts designed or intended to convert a firearm into an assault weapon, that may be assembled if those parts are in the possession or under the control of the same person.

Other Firearms

- Other Firearms must be compliant with all Federal and Connecticut State Regulations which features include the following:
 - Must be categorized as an Other Firearm when receiving.
 - Minimum 26 inches overall length in the shortest configuration.
 - Minimum 12-inch barrel length.
 - Stocks are prohibited.
 - Must be 21 to receive.
 - Manufacturer cannot be on the Assault Weapons List for the State of Connecticut.
 - Cannot be a centerfire detachable magazine.
 - (Mossberg Shockwaves are the only exception now.)

Receiver/Frames

- Must be serialized and background check performed to pick up.
- Manufacturer cannot be on the Assault Weapons List for the State of Connecticut.
- We will only transfer Receivers to any person who has the following criteria.
 - Active Military
 - Active Law Enforcement

Magazines

- Any large capacity feeding devices that are over a 10-round capacity are not acceptable in the State of Connecticut.
 - If your incoming firearm transfer has a more than 10-round capacity detachable magazines they will be removed prior to you receiving your firearm.
 - You will **NOT** be compensated for any magazine over 10-round capacity that are confiscated due to Connecticut legislation laws.

NFA (Suppressors/Machine Guns)

We do not conduct transfers of NFA items at this time.
